It is hereby recognized that all equestrian sports involve inherent risk and that no helmet or protective equipment can protect against all foreseeable injury. I hereby accept this risk and hold harmless the host facility, their officials, organizers, agents, employees and their representatives.

I acknowledge that any activity involving horses is high risk including but not limited to: (a) the propensity of any equine to behave in ways that may result in injury, harm or death to persons on or around them and to potentially collide with, bite or kick other animals, people or objects; (b) the unpredictability of an equine's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals and hazards such as subsurface objects; (c) the potential for other participants to behave in a negligent manner that may contribute to injury to themselves or others, including failing to act within their abilities to maintain control over an equine. In consideration given for my Participation in this short course event being held at **Buxton Equestrian** ("HOST"), on May 29/July 24/Aug 22, I and my heirs, executors, administrators and assigns agree;

- To Waive ALL Claims that I might have against the Organizing Committee, Trilogly CT series, as well as their directors, officers, agents, representatives, employees, officials, members, volunteers and the owners or occupier of the land upon which the event is held (all of them collectively hereinafter referred to as the "HOST"); and
